On average, mass shootings have occurred once every two weeks over the last decade which is a major factor behind why social scientists have started to ask whether mass shootings play a causative role in civilian decisions to purchase guns. Particular types of mass shootings are hypothesized to have driven and continue to bring about increased levels of civilian firearm purchases through different pathways and combinations of variables – those that feature high fatality counts; arise in areas of cultural importance, are ideologically motivated. Since 1994, the number of civilian-owned firearms in the US has doubled to around 398 million while the population only grew by 70 million.
