Mathematics previously proved theorems, axioms, and—in case of abstraction from nature—some basic properties that are considered true starting points of the theory under Mathematics is a field of study that discovers and organizes methods, theories and theorems that are developed and proved for the needs of empirical sciences and mathematics itself. There are many areas of mathematics, which include number theory (the study of numbers), algebra (the study of formulas and related structures),

geometry (the study of shapes and spaces that contain them), analysis (the study of continuous changes), and set theory (presently used as a foundation for all mathematics)

The values of x that satisfy the equation are called solutions... $ax^2+bx+c=0$, where the variable x represents an unknown number, and a , b , and c represent known numbers, where $a \neq 0$. (If $a = 0$ and $b \neq 0$ then the equation is linear, not quadratic.) The numbers a , b , and c are the coefficients of the equation and may be distinguished by respectively calling them, the quadratic coefficient, the linear coefficient and the constant coefficient or free term.
