Other contaminants found in prints result from contact with different materials in the environment. In general, surfaces can be characterized as porous, nonporous, or semiporous. These prints consist of a combination of different chemicals that originate from natural secretions, blood, and contaminants. The beginning of this manual is a list of processes and procedures for different surface types. Natural secretions mainly derive from the eccrine and sebaceous glands and contain known chemical components. Also included are processing sequences that specifically involve prints that are left in blood. Eccrine gland secretions from the fingers, hands, and feet are both organic and inorganic, but only organic materials are secreted from the sebaceous glands. Understanding these characteristics will aid in processing an item for latent prints. Latent prints can be found on all types of surfaces. The identification of latent print evidence is often key in solving a crime. A latent print results from the reproduction of friction ridges found on parts of the fingers, hands, and feet.
